

PUBLICATION RIGHTS AGREEMENT

1. The Author of the Column titled or tentatively titled: _____

_____ hereby represents to Hutchinson Tanker Ltd., publisher of *HVACR Business*, that: (a) the Column is or will be an original work created solely by Author; (b) the Author alone owns or will own any copyrights in the Column and has the sole right and authority to assign the rights in and to the Column; (c) to best of Author's knowledge and belief, the Column does not or will not infringe upon or misappropriate property rights of any other person or company; and (d) the Column does not violate or conflict with, in any manner, the obligations of Author to any third party. This agreement is applicable for any work contributed between Jan. 1, 2008, and Jan. 1, 2010.

2. In consideration for Hutchinson Tanker's review and/or editing of the Column, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Author hereby irrevocably grants and assigns to Hutchinson Tanker the following, world-wide rights:

- (a) The exclusive right of first publication of the Column.
- (b) The right to make unlimited copies, reprints, republications and/or uses of the Column as a whole, or using any part thereof, in any form or print or any other form of media, now known or hereafter devised, including electronic means.
- (c) The right to publish and/or distribute the Column by any means of communication, broadcast, reproduction, display or delivery, including electronic, magnetic, phonographic, optical, or other form of programming, indexing, retrieval, manipulation or display now known or hereafter devised.

3. Author hereby authorizes Hutchinson Tanker to edit, abstract, translate into any and all foreign, html, or computer languages, manipulate, outline, expand and/or retitle the Column, create derivative works, and to insert graphic material in the Column in conjunction with its use of the Column. Any and all editorial revisions or deletions may be made by Hutchinson Tanker, at Hutchinson Tanker's sole discretion.

4. If any claim is made by any third-party against Hutchinson Tanker in connection with, or related to the Column, Author will cooperate with Hutchinson Tanker in the defense of such claim. If any copyright in the Column is, in Hutchinson Tanker's opinion, infringed by any third party, Hutchinson Tanker may, at its sole discretion, cost and expense, take such legal action (in Author's name, if necessary) as may be required to restrain the infringement of the copyright and/or seek damages. Author agrees to cooperate with Hutchinson Tanker in connection with any such action. Nothing in this paragraph, however, shall obligate Hutchinson Tanker to institute or pursue any copyright infringement claim or other proceeding.

5. This Agreement may be amended, from time to time, by the mutual agreement of the Parties, in writing.
